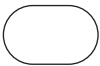

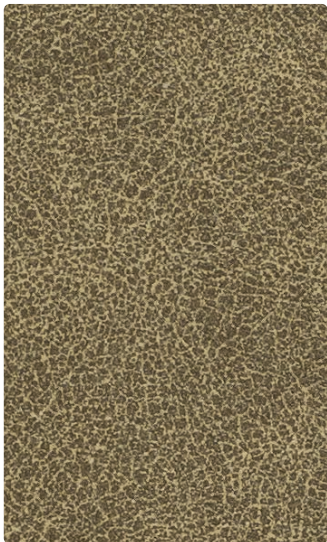

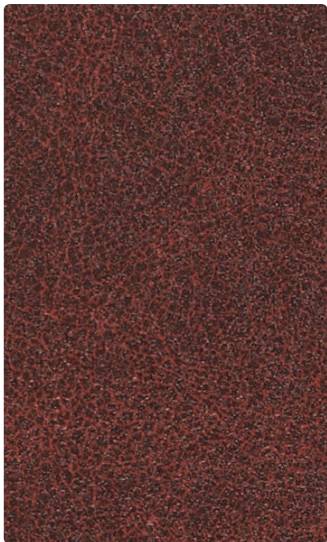

CLEANING INFORMATION

**WS:** Water/Solvent Cleaner – Spot clean, with a mild solvent, an upholstery shampoo, or the foam from a mild detergent. When using a solvent or dry cleaning product, follow instructions carefully and clean only in a well-ventilated room. Avoid any product that contains carbon tetrachloride or other toxic materials. With either method, pretest a small area before proceeding. Always rinse promptly with clean water.

**BC:** Bleach Cleanable – 1 part bleach, 9 parts water = 10% bleach, 90% water solution. Do not clean/disinfect fabric for longer than 10 minutes using the 10% bleach solution. Always rinse promptly with clean water after applying the bleach solution. Failure to do so will void any and all warranties.

Prompt cleaning is always recommended. Recommended cleaning steps are listed by type of stain.  
**Regular Cleaning and Maintenance** (Dirt, Dust, Grime): Clean the soiled area with mild soap and water, then rinse with fresh water and wipe dry with a clean cloth.  
**Food Stains/Oils** (Ketchup, Chocolate, Coffee, Tea, Juice): Wipe affected area with a soft cloth or soft bristle brush using a non-abrasive cleaner, for example Formula 409® or Fantastik®. Rinse with fresh water and wipe dry.  
**Healthcare** (Blood, Urine, Betadine, Disinfectant): Clean the soiled area with a 20% solution of household bleach and water. Rinse the cleaned area with fresh water after applying the bleach solution.  
**Difficult Stains** (Eye Shadow, Mascara, Lipstick, Crayon, Grease, Mustard): Clean the soiled area with 50% solution of isopropyl (rubbing) alcohol and water. Alternately, use a 25% solution of bleach and water. Rinse the cleaned area with fresh water after applying the alcohol solution (bleach solution).  
**Ink Stains** (Ballpoint Pen, Permanent Marker, Paint): Removal of these stains varies depending on type of ink, color and length of time before cleaning. Rub the marked area with undiluted isopropyl (rubbing) alcohol. Rinse the cleaned area with fresh water promptly after applying the alcohol. Note: To achieve the best results it is recommended to clean the stain immediately.

**NOTE:** This product may withstand the regular use of commercial cleaners and disinfectants not listed above. It is recommended to test the cleaners on a sample prior to use. Please refer to the Mayer Fabrics web site or contact customer service for approval of unlisted cleaning agents prior to use.
